### OPINION

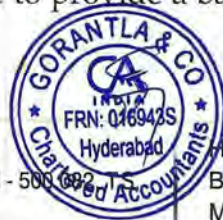
We have audited the accompanying statement of standalone financial results of **GACM TECHNOLOGIES LIMITED (Formerly STAMPEDE CAPITAL LIMITED)** ("hereinafter referred to as the Company"), for the year ended 31<sup>st</sup> March, 2025 (the "Statement"), being submitted by the company pursuant to the requirement of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing Regulations").

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid statement of standalone financial results:

### BASIS FOR OPINION

### OPINION

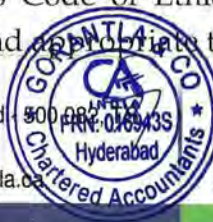

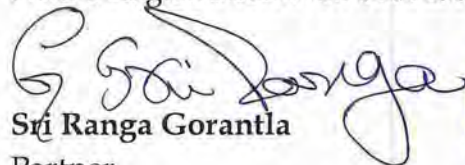
